The overall aim of FIT4FOOD2030 is to support the European Commission (EC) with the development and implementation of the FOOD 2030 research & innovation policy framework, to future-proof the European food systems. The main objective towards that is to create a multi-stakeholder platform – the FOOD 2030 Platform. The FOOD 2030 Platform, connecting stakeholders in the European food system at multiple levels (cities/regions, countries, and Europe), will make Research & Innovation (R&I) policies on Food and Nutrition Security (FNS) more coherent, build competences of current and future researchers, entrepreneurs, policy-makers, and society at large, and raise awareness of FOOD 2030.

There were no deliverables completed in 2018 for which Wageningen is primarily responsible (WP2, 3, 4 and 5). Deliverable 2.3 was suspended to February 2019.

Highlights and deliverables in 2018 / so far (this information can be published on a website of the TKI/Topsectors)

- The Dutch Ministry of Agriculture has asked us to organize the first Dutch Policy lab meeting. The organization of this meeting is closely connected to the policy support work we do for the Ministry of Agriculture, so both activities are connected. This first policy lab had the objective to find out what how current research and innovation themes should be changed to support the SDG goals, the Food 2030 goals and Dutch policy goals.
- The EU has committed to the goal of SDG2 *Ending Hunger* and the goal of SDG13 *Climate Action* (made operational by the Paris agreement under UNFCCC). We explore synergies and trade-offs using indicators are part of the official monitoring system of the EU for the SDGs. We make of a database of scenario drivers from SUSFANS deliverable D10.2 and quantify this new set of indicators using advanced modelling tools.
- Clearly, the results indicate that synergies between the two SDG goals exist in the EU, in all the three scenarios, and in the responses to changing social economic conditions. When zooming into the individual countries in the EU, however, the abovementioned synergies between the two SDG goals become less clear-cut.
- Alignment with FIT4FOOD2030 RRI processes at national and EU level have been accomplished

through alignment with several Policy labs (Lithuania, Flanders) and the EU Think Tank.

- For WP3, WECR contributed to the long list of 150 food system cases, included in Deliverable 3.1 (M14, due date: 21-12-2018): Report on detailed data set from identified food systems R&I cases from Europe and across the globe. Furthermore, WECR contributed to the organisation of the WP3 workshop to be organised on 17 April 2019.
