## **European Funding News: Horizon Europe**

# The ERC awards €761m to the next generation of scientists in Europe (4 September 2025)

The European Research Council (ERC) has selected 478 early-career researchers across Europe to receive this year's Starting Grants. With a total funding of €761 million, these grants support excellent research across diverse fields, including physical sciences and engineering, life sciences, and social sciences and humanities. The backing will help researchers at the beginning of their careers to launch their own projects, build research teams and pursue their most promising ideas.



#### Projects selected for funding

As part of the EU's Horizon Europe programme, these ERC grants will help researchers make discoveries across a wide range of fields. The grantees include a researcher in the Netherlands exploring new ways to make artificial touch feel more natural and realistic; an Austria-based scientist investigating how aging reshapes human tissues and triggers disease; a researcher in Estonia studying whether attention deficit hyperactivity disorder (ADHD) in adults mirrors childhood ADHD; and another scientist, based in Spain, examining how plants protect themselves from excessive sun exposure.

These are just some examples of the research that the new grantees will conduct.

#### Facts and figures

The successful candidates plan to carry out their projects at universities and research centres across 25 countries, including Germany (99 grants), the UK (60), the Netherlands (44), and France (41). They come from Europe and beyond, with 51 different nationalities amongst the grantees, notably Germans (87 researchers), Italians (55), French (33), and UK and Spanish researchers (32 each).



This competition attracted 3 928 proposals, marking a 13% increase in demand from last year's Starting Grant call. Just over 12% of the proposals will be funded.



The number of women grantees remain fairly stable with 42% female winners in this year's Starting Grants, and 44% in 2024, and 43% in 2023.

A Starting Grant amounts to €1.5 million for a period of up to five years. However, additional funds can be made available to cover costs related to moving from a country outside the EU or associated countries, purchasing major equipment or the access to large facilities, or major experimental and fieldwork-related costs.

This round of grants is estimated to create some 3 000 jobs within the teams of the new grantees.

# New versions of draft Cluster 5 and 6 work programmes for 2026-27 are out (1 September 2025)

Horizon Europe's funding for climate, energy and mobility shrinks by a third in latest draft



Two new versions of draft Horizon Europe work programmes are out, and they include a big decrease in funding for collaborative climate, energy and mobility research in 2026 and 2027.

The total direct funding for Horizon's Cluster 5, which covers big collaborative climate, energy and mobility projects, is down by about a third. Compared with the previous version from May, the draft budgets have shrunk from €1.759 billion to €1.218 billion in 2026, and from €1.296 billion to €862 million in 2027.

But not the entire decrease is money gone. Some of the funding has simply moved elsewhere in the Horizon budget, such as almost €500 million for Horizon Europe Missions and the €150 million for big climate-friendly tech demonstrator projects, which will be described in a separate annex.

The new draft budget lines are roughly in line with the previous years of Horizon Europe, such as €1,662 billion in 2023, €1,404 billion in 2024 and €1,231 billion in 2025.

Elsewhere, the strategic planning committee has cut the budgets for various topics as well as moved topics around the different calls. The total number of big calls falls from 18 to 16, but most of the topics have been reabsorbed by other calls.

This is likely not the last set of changes for the work programme, as the Commission and member states work towards finalising the plans for the last two years of Horizon Europe by the end of 2025. Up until then, anything can change. Similarly, over the summer the Commission published a leaner version of the work programme for Cluster 6, which covers research on food, bioeconomy, natural resources, agriculture and environment.

The budgets for both years are again down by about a third in the newest version, from around €900 million each year to just over €600 million. But in the case of Cluster 6, this is largely due to the money moving around the Horizon budgets, with much of the funding transferred to the work programmes for Horizon Europe Missions and the New European Bauhaus.

# Applications for ERC Advanced Grants 2025: Facts and figures (1 September 2025)

The ERC Advanced Grants 2025 call closed for applications on 28 August 2025. These are the preliminary data on the submitted proposals:

- The ERC received 3 329 proposals **31% more** than last year and **82% more** than the year before that.
- The **highest number of applications** were submitted in **Physical Sciences and Engineering** (1 341), followed by Social Science and Humanities (1 013), and Life Sciences (975).
- Women submitted 840 proposals (25.2%), higher share than in the past two years.

In its Work Programme 2025 https://ec.europa.eu/info/funding-tenders/opportunities/docs/2021-2027/horizon/wp-call/2025/wp\_horizon-erc-2025\_en.pdf, the ERC earmarked €683 million for an estimated 276 Advanced Grants. The ERC is now starting the evaluation of the proposals. The selected projects will likely be announced in the spring of 2026. ERC Advanced Grants are designed to Support for excellent researchers at the career stage when they are already established leaders with a recognised track record of research achievements. The principal investigators must demonstrate the ground-breaking nature, ambition, and feasibility of their research proposal.

# Belgian universities renew call to suspend Israel from Horizon Europe (21 Aug 2025)

Starvation in Gaza means Israel has broken its association agreement with the EU, they say. Ljubljana University has also joined their call

Belgian university rectors have repeated their call to suspend Israel from the EU's Horizon Europe research and innovation programme. In its war in Gaza, Israel has failed to honour its association agreement with the EU, the rectors argue, which states that both parties must respect human rights.

"If this foundation is systematically undermined, consequences must follow. Otherwise, our European values risk becoming hollow words," **they said in a statement** https://nieuws.kuleuven.be/en/content/2025/public-statement-by-university-rectors-on-the-situation-in-gaza on August 9.

On August 18, the University of Ljubljana also called on the EU https://www.uni-lj.si/en/news/2025-08-18-the-senate-of-the-university-of-ljubljana-deliberated-on-further-cooperation-with-israeli-universities-and-institutions to suspend Israel from the programme, citing "reports of genocidal acts against the population" in Gaza. It said it would not join Horizon Europe project consortia with Israeli institutions.

Europe is currently mulling whether to launch scientific sanctions against Israel in response to the country's war on and blockade of Gaza. The EU-Israel association agreement underpins Israel's association to Horizon Europe, from which the country has received €856 million so far.

The World Health Organization has warned that starvation <a href="https://www.who.int/news-room/speeches/item/who-director-general-s-opening-remarks-at-the-media-briefing-23-july-2025">https://www.who.int/news-room/speeches/item/who-director-general-s-opening-remarks-at-the-media-briefing-23-july-2025</a> is unfolding in Gaza, and has documented 21 children under five dying of hunger so far this year. Israel is blocking food trucks from entering the territory, the <a href="https://news.un.org/en/story/2025/08/1165552">https://news.un.org/en/story/2025/08/1165552</a> UN said earlier this month and, since May, at least 1,373 Palestinians have been killed while seeking food, largely by Israeli forces.

While EU leaders have upped their condemnation of Israel in recent months, this has not yet translated into any scientific sanctions, one tool the bloc can use to pressure Israel to change course.

Last month, the European Commission proposed excluding Israeli entities from receiving new European Innovation Council Accelerator grants, which typically fund start-ups. Israeli firms have already received €170 million in Accelerator grants, including for work in dual-use fields such as drones.

But in discussions before the August break some EU countries, including Germany, still blocked the proposed sanctions.

This latest call by Belgian rectors will increase pressure on EU states to act when officials return from their holidays next week

"We cannot remain silent in the face of the inhumane conditions and deep humanitarian crisis in Gaza," say the rectors in their statement.

"What has been unfolding in Gaza over the past months violates every principle of human dignity: more than 60,000 civilian casualties, the blocking of humanitarian aid, and a worsening famine," they say.

# **European Funding News: FP10**

### The road to FP10 is paved with missing details (4 September 2025)

Brussels research lobbies, together with leading MEP Christian Ehler, are calling for more detail and clarity about the European Commission's €175 billion plan for the tenth Framework Programme (FP10).

Their comments came as research Commissioner Ekaterina Zaharieva asked the research community to continue its "support" for the Commission so that "we still have a really strong standalone [programme] with a doubled budget" when negotiations conclude in 2027.

When the Commission presented its proposal in July, the research community was thrilled to see Horizon Europe remain a standalone programme after months of uncertainty and intense haggling among the Commission's services over a plan to dismember the programme and incorporate it in a future European Competitiveness Fund (ECF).

The programme remained "standalone" with a budget nearly twice the size of the current programme, but a large chunk of that money is still slated to be spent under a joint jurisdiction with the ECF. Just how that will work has not yet been set out in detail by the Commission. It also promised to simplify the programme, allocate more money to fundamental research and boost the European Innovation Council.

Research stakeholders are now wondering how exactly the Commission will deliver on those promises, as MEPs and member states are gearing up for years of negotiation on a final budget, as well as the content and structure of the programme. An agreement is envisioned by the end of 2027.

Speaking on September 2 at an event organised by the Guild of European Research-Intensive Universities and the League of European Research Universities (LERU), two of the most prominent research lobbies in Brussels, Zaharieva urged the audience to "continue to support" the Commission, but did not offer details about the gaps in the regulation. Research lobbies and MEPs alike are concerned about the lack of clarity in the regulation put forward by the Commission in July. Important details on how the Commission plans to simplify the programme and how defence research will be incorporated into a largely civilian programme are still missing.

"There are a lot of questions where the text is simply incomplete," said European People's Party MEP Christian Ehler, who has served as a co-rapporteur for Horizon Europe and a rapporteur for the rules of participation in Horizon 2020. "We have an interesting situation where the programme is entwined in the European budget with the European Competitiveness programme," but the Commission has yet to explain how it will "formulate that" in practice, he told delegates to the conference.

Then there is the issue of simplification. Zaharieva reiterated the need to streamline Horizon Europe to make it "easier to access, faster to manage and more flexible," so that researchers "focus on science, not on paperwork."

But the Commission's plans are too vague, Ehler said. "Beyond the disputed concept of lump sums, there is very little detail on how matters will be simplified."

#### Missing details

Kurt Deketelaere, secretary general of LERU, wants the Commission to make available a precise budgetary breakdown for Horizon Europe. This is currently missing in the Commission's proposal. "We need, in the FP10 text, in the European Competitiveness Fund text, in black and white, what every part of the programme is going to get," he said.

For example, the Commission intends to nearly double the budget for Pillar 1 in efforts to support the expansion of the European Research Council (ERC). But when looking at what this increase represents out of the total budget, the ERC is in fact receiving the same share as it currently has under Horizon Europe, Deketelaere said.

"For a number of those topics, even if they win cash-wise, it's a little bit disappointing percentage-wise," he added.

DUT is focused on promoting transnational projects that tackle urban challenges, aiming to assist cities in their shift toward a more sustainable future. Themes of this Call are about the urban energy transition, mobility and circular economy. Transnational interdisciplinary consortia from at least three participating countries are invited to apply. NWO invites Dutch researchers to apply for funding.


#### The DUT Partnership

The DUT Partnership https://dutpartnership.eu/ aims at urban change in a global context. It focuses on sustainable urban development and aims to facilitate knowledge and impact by forming and expanding networks of societal and scientific partners. DUT wants to boost the urgently needed urban transformations towards a sustainable future with enhanced quality of life in cities.

#### Aim of the Call

Many complex challenges of today and the future must be addressed within cities and by urban communities. Urban areas are the places where transformations are required to secure a sustainable future. The purpose of this Call for proposals is thus to support transnational projects addressing these complex urban challenges to help cities in their transition towards a more sustainable economy and functioning.

In this Call for proposals these challenges are grouped into three Transition Pathways: Positive Energy Districts, the 15-minute City and Circular Urban Economies. NWO takes part in seven of the nine Call topics offered in this call for proposals, with funding available for *strategic research*:



#### Apply for funding

The application process consists of two stags. The deadline for pre-proposals is 17 November 2025 (13:00 CET). The deadline for full proposals is 23 April 2026 (13:00 CEST).

The second round of the NL-CGIAR Senior Expert Programme II is now open for applications. This programme enables experienced researchers working at Dutch universities, universities of applied sciences and other research institutes to contribute to international research Programmes and Accelerators of CGIAR, the world's largest global organisation for agricultural research. The programme reimburses their personnel costs, thereby allowing them to engage with CGIAR (Science) Programs and/or Accelerators. The deadline for applications is 20 January 2026.

#### About this call

The projects range from research on paint to soap and from coatings to food. Using Al and high-throughput experiments, the projects will conduct research into a more sustainable and efficient chemical industry.

The aim of this call is to accelerate the search for chemicals with the right desirable properties. High-throughput experiments, in which many experiments are carried out simultaneously, enable large amounts of data to be collected. This data is analysed using artificial intelligence (AI) to identify patterns. These patterns can be used to predict all kinds of properties of new chemicals, such as taste, smell or solubility. Ultimately, this will be integrated into a fully automated RobotLab. The RobotLab itself is not part of this call.

This call was a collaboration between NWO and National Growth Fund project Big Chemistry. This ensures a good connection between scientific research and practical implementation.

A total of nearly 2.8 million euros in NWO funding has been granted, and the eight projects have jointly raised an additional 556,000 euros in co-funding. It is noteworthy that the consortium partners come from both the Netherlands and abroad.

NWO is investing an additional 30 million euros in the NWO Talent Programme Vidi. Partly because the abolition of starter and incentive grants has left a gap in funding for this group of talented researchers. Stimulating scientific talent is one of NWO's priorities, and Vidi is an important part of the NWO Talent Programme.

The extra budget of 30 million euros will be added to the 2024 Vidi round, creating more scope for awarding grants. This amounts to just over 30 additional grants (of 850,000 euros) spread across all scientific disciplines. NWO will decide on the allocations this fall.

Vidi is a funding instrument from the NWO Talent Programme. The Vidi grants are aimed at researchers who are in the transition to leadership. They also have academic qualities that exceed the norm and demonstrate the development of leadership and mentoring skills. The Vidi grant funds innovative scientific research in all scientific fields and gives researchers the opportunity to set up or expand a research group.

#### Why is the extra budget going to the Vidi grants?

After extra budget was recently made available, because NWO receives interest on amounts that are still awaiting final allocation (for example because of assessment procedures that have to take place before we can distribute the budget) it was decided to invest this specifically in our Talent Programme. This decision was partly motivated by the abolition of the starter and incentive grants. By adding more resources to this programme, we are creating extra opportunities for more talented researchers to develop themselves, especially in times of cutbacks in research and science. We prefer to use the freed-up budget for research as soon as possible. The Vidi decisions will be made this fall, so this is the first opportunity to put the extra funds to good use. It therefore only concerns the Vidis and is not a structural investment in the NWO Talent Programme, which means it will have no effect on the upcoming Veni, Vidi, and Vici rounds.

Six application-oriented projects can start with funding from the Open Technology Programme from the NWO domain Applied and Engineering Sciences (AES). NWO is supporting these application-oriented projects with more than 5.5 million euros. Industry partners and other organisations are contributing another amount of over 885.880 euros.

The granted projects include topics such as:

- Expanding the electron microscope toolbox with novel microwave technology, enabling ultrashort exposure
  times to study extremely fast processes occurring in materials, while maintaining the state-of-the-art precision
  of imaging and spectroscopy. This will help to better understand and further develop advanced quantum
  materials (Project: Microwave-cavity-based ultrafast electron microscopy and spectroscopy)
- Development of time-scale-space adaptive meshfree method for urban wind simulation utilizing Dutch Airborne
  Laser Scanning open data. Given high detail in point clouds and adaptive nature of point distribution, the
  method is expected to be superior in quality (Project: POINT-TWINS: Point clOud-based dynamic continuousscale adaptive urban WINd Simulat
- Using flower pigmentation patterns as a model system to uncover the processes and genes involved in
  establishing and maintaining post-transcriptional gene silencing (PTGS) differently between neighbouring cells,
  enabling the application of such insights in crop breeding programs (Project: Precision Patterns in Petal
  Pigmentation: Genetic, sRNA, and Epigenetic Landscapes Shaping Flower Pigmentation Patterns)

# NWO: Choose knowledge for a resilient and future-proof Netherlands (1 September 2025)

Choosing knowledge means choosing a resilient and future-proof Netherlands. That is the key message of NWO in its election pledge. It identifies three specific opportunities for NWO and politicians to work together to create a strong knowledge-based country. In addition, as a partner in the Knowledge Coalition, NWO emphatically endorses the call to the next cabinet to now work concretely toward the goal of spending 3% of our GDP on research and development (R&D) by 2030.

The three opportunities identified by NWO are: knowledge for major societal issues, scientific talent, and a national digital infrastructure strategy.

#### Knowledge for major societal issues

Because NWO is the party with an overview of the entire Dutch research field and has the expertise to bring parties together, NWO sees two new opportunities to contribute more to the major issues facing our country from this role. Firstly, the funder is asking for a coordinating role in addressing other societal issues (such as security and the energy transition) and in coordinating collaboration between science and practice. Secondly, NWO is offering to work on a new regional innovation program, bringing together all knowledge institutions in the area with all societal partners and the (regional) business community.

#### Proud of talent

Research is people work, and the Netherlands is fortunate to have a continuous stream of highly talented and highly educated young people with creative ideas and great research ambitions. However, for years there has been a *brain drain* from Europe to other countries, while talent that wants to work here is desperately needed. The bright minds of tomorrow must be trained here and retained for science and business. NWO's Talent Program offers researchers opportunities for further development. That is why NWO is requesting an extension of its mandate to review this Talent Program and make it future-proof, so that 1) talented practice-oriented and application-oriented researchers can also apply, and 2) the Talent Program is once again seamlessly aligned with its European equivalent.

#### National digital infrastructure strategy

Digitization has completely changed science, and there is no end in sight. At is rapidly conquering the field of research and raising new questions. The day when quantum computers become a reality is fast approaching. At the same time, the national supercomputer Snellius is due for replacement, and we are increasingly realizing that we no longer want to be dependent on 'big tech'. Ideally, the Netherlands as a knowledge economy should be digitally autonomous (or within a European context), so that scientific values such as reliability, transparency, and security remain guaranteed.

#### **Knowledge Coalition**

As a partner in the partnership between knowledge institutions and the business community (the Knowledge Coalition), NWO wholeheartedly endorses the call to continue investing in knowledge and talent – the raw materials for a future-proof Netherlands – with the aim of spending 3% of GDP on R&D by 2030. According to the Knowledge Coalition, achieving this goal will require €2 billion annually, rising to €3.5 billion in 2029.

#### Specifically, the Knowledge Coalition makes the following recommendations to the next cabinet:

• A new instrument for strategic innovation programs;

- Better coordination and more resources in our instruments for EU funding of R&D, so that no EU budget remains unused due to a lack of co-funding or matching;
- Modernization of scientific infrastructure via OCW and NWO, and experimental and new valorization infrastructure at public knowledge institutions, such as TO2 institutions;
- Establishment of a national investment institution for start-ups and scale-ups (e.g. through the use of pension funds):
- Stable funding for scientific, applied research.

Starting today, knowledge institutions can submit nominations for the Tulip Fund, NWO's new instrument that enables universities to attract renowned international scientists from outside the EU. Nominations can be submitted until 31 March 2026.

#### Purpose of the call

The purpose of this call for proposals is to enable research organisations to appoint top researchers or talented individuals from abroad who wish to continue their research in the Netherlands due to growing threats to academic freedom.

The fund is intended for scientists with a proven track record who are among the best in their field worldwide. With this fund, NWO aims to contribute to strengthening the Netherlands' international research position and creating powerful, sustainable research groups around excellent scientists.

#### Scientific and societal reinforcement

This boost will strengthen the Netherlands' leading scientific position in the world. The research carried out by these researchers will strengthen the Netherlands and Europe scientifically and socially. It may involve fundamental or applied research. There are no restrictions on the content of the research. In addition, this boost contributes to academic freedom, international cooperation and the independence of researchers, not only in the Netherlands, but wherever our influence reaches.

## Study warns of populism's impact on science (4 September 2025)

The rise of populist and anti-science parties is creating a "climate of fear" among researchers, according to a recent publication reported by Science Business. According to co-author Andrés Rodríguez-Pose, this leads to less research and innovation. Rodríguez-Pose warns that populism and low levels of research and innovation reinforce each other. "Support for extreme parties will likely lead to less innovation, as we demonstrate in our article. But as soon as there is less innovation, you create more economic decline, which will ultimately lead to anti-establishment positions." #### China and the US dominate new WIPO innovation ranking (4 September 2025)

The World Intellectual Property Organization (WIPO) has published its latest ranking of global innovation clusters. For the first time, venture capital activity, or investments in young companies that bring scientific knowledge to market, is also included. China and the United States dominate the ranking, with both having multiple clusters in the top 10. The Netherlands is also represented. The Amsterdam–Rotterdam cluster ranks 22nd, driven by TNO, Shell, and Delft University of Technology. Eindhoven ends in 65th place, but achieves a global top ten ranking when its score is compared to population density. ## Draghi: EU urgently needs reform to address US wake-up call (28 August 2025)

The European Union needs drastic reforms in the short term to play a key role in a new world dominated by war and ruthless geopolitics. This was the argument of the former ECB chief during a political meeting in Rimini, Italy. "For years, the European Union believed that its economic size, with 450 million consumers, entailed geopolitical power and influence in international trade relations. This year will be remembered as the year in which this illusion evaporated," Draghi said. According to Draghi, President Trump's US trade tariffs are "a very brutal wake-up call" for the EU. China, too, reportedly no longer sees the EU as a full partner. Draghi advocates for drastic reforms to strengthen the internal market, for example, by issuing common EU debt to increase investment in defense, R&D, common infrastructure, and disruptive technologies.

### Trump Tightens Control Over Research Funding (28 August 2025)

US President Trump has signed an executive order that aims to further tighten control over the process of distributing research grants. According to Nature, the executive order, "Improving Oversight of Federal Grantmaking," stipulates that each federal agency will appoint an official responsible for developing review processes that align with the president's wishes. Critics argue that this shifts the review of research funding from science to politics. For example, funding may not be allocated to promote "anti-American values." The measure takes effect immediately and has immediately raised concerns among experts and the scientific community.

## ESB: Defense spending can strengthen the economy (1 September 2025)

The economic journal Economisch Statistische Berichten (Economic Statistical Reports) has published an article on the potential economic effects of the NATO agreement to structurally spend 5% of GDP on defense.

According to the analysis, the economic return depends heavily on implementation. Investments in defense R&D, in particular, could generate broad economic added value in the long term. Four preconditions would be decisive for this: clear delivery obligations, earmarking funds for European defense companies, contextual coordination, and sound financing.

# Research points to innovation gap between management and employees in the Dutch central government (28 August 2025)

Managers and employees of the Dutch central government experience the innovation climate within the government in very different ways. This is evident from research by Venster (ICTU) among 4,800 civil servants, as part of a large-scale OECD study on job satisfaction among civil servants in eight EU countries. Civil servants rate the innovation climate an average of 3.1 on a scale of 1 to 5. It is striking that the perceptions of managers and employees vary considerably. For example, managers are predominantly positive about the innovation climate, while many employees experience less support and less room for error. The use of Al also remains limited: two-thirds of civil servants indicate they never use the technology.

## Cabinet presents action plan to boost innovation (21 August 2025)

Nine measures should ensure that the Netherlands invests 3% of GDP in research and development (R&D) by 2030. The cabinet presented these measures in the 3% R&D action plan in July. The Netherlands currently has a target of 2.2%. According to calculations by TNO and the Rathenau Institute, an additional public investment of an estimated 2 to 4 billion euros annually is needed. The cabinet wants to explore, among other things, the establishment of a National Agency for Disruptive Innovation (NADI), based on successful international examples such as DARPA in the US and SPRIND in Germany. Furthermore, the cabinet wants to mobilize 3 billion euros in capital for R&D-intensive scale-ups by entering into discussions with institutional investors such as pension funds.

In its response, the AWTI calls on politicians to invest an additional 0.5 percent of national income annually in a targeted, long-term, large-scale, and strategic research and innovation facility.

# €50 million fund to attract top international scientists to the Netherlands (21 August 2025)

The Dutch government and the Netherlands Organisation for Scientific Research (NWO) have jointly allocated €50 million for a fund to attract top international scientists from outside the European Union to the Netherlands. Before the summer, Minister Bruins informed Parliament about the establishment of the Tulip Fund. In the Spring Memorandum, the government allocated €25 million for the fund. NWO has decided to double this amount. It is expected that approximately 50 top scientists can be attracted. The Young Academy has criticized the fund and calls for attention not only to scientific excellence but also to protect scientists who cannot perform their work safely.

WGO offers information, guidance, and training on available funding opportunities and on effective, efficient application processes. The team includes specialized advisors, i.e. Grant Support Officers, Policy Officers, Liaison officers from various science groups and Officers dealing with Co-creation Value & Impact.

This expert team—providing second-line support services—delivers technical and personalized advice on specific funding programs and themes. They work closely with the liaison offices, which provide first-line support within the science groups.

WGO primarily focuses its generic support on Horizon Europe (including ERC, MSCA, Research Infrastructures under **Pillar 1**; Clusters, Missions, and Partnerships under **Pillar 2**, and EIC and WIDENING under **Pillar 3**), and on NWO-programmes (such as the **Talent Programme** (Veni-Vidi-Vici), **Open Competition M1 and M2** (OC), **Open Technology Programme** (OTP), and **Research along Routes by Consortia** (NWA-ORC)). More specific support is given to large initiatives WUR coordinates.
