# New partnership between African Academy of Sciences and the European Research Council to boost scientific collaboration (23 October 2025)

A new initiative to encourage collaboration between leading African researchers and European Research Council (ERC) grantees was signed by the European Commission and the African Academy of Sciences (AAS) in Brussels on 23 October. It opens opportunities for researchers supported by the AAS to temporarily join teams led by ERC grantees in Europe.



The agreement encourages beneficiaries of the 'African Research Initiative for Scientific Excellence – Pilot Programme' (ARISE-PP) to pursue research collaborations with ERC-funded researchers. The ARISE-PP is founded on the AU-EU High-Level Policy Dialogue on Science, Technology, and Innovation, and the AU-EU Innovation Agenda. ARISE-PP provides a platform and pathway for R&I exchanges contributing to sustainable and inclusive development, economic growth, and job creation.

The new agreement was signed by Director-General Marc Lemaitre of the European Commission's Directorate General for Research and Innovation and AAS President Professor Lise Korsten, in the presence of Deputy Director-General Myriam Ferran of DG International Partnerships and ERC President Professor Maria Leptin.

With this new agreement, all partners committed to deepen the cooperation in frontier research between the EU and the African Union.

#### Background

This initiative, officially called an 'implementing arrangement' https://erc.europa.eu/apply-grant/additional-opportunities#International-Arrangement-funding, forms part of the ERC's global outreach strategy that aims to make Europe a hub for scientific talent. It follows a string of such initiatives that have been launched over the years since 2012.

The new agreement is based on the 'African Research Initiative for Scientific Excellence – Pilot Programme' (ARISE-PP) worth €25 million, provided by the Neighbourhood, Development and International Cooperation Instrument – Global Europe (NDICI – Global Europe). The ARISE-PP is an innovative research and innovation support programme of the AAS, implemented by the AAS in partnership with the African Union (AU) and the European Union (EU).

### Egypt officially joins Horizon Europe (21 October 2025)

The EU and Egypt have formally signed a deal agreed in April that gives Egyptian researchers and innovators access to all parts of the programme



Egypt has officially joined the Horizon Europe, becoming the second African country associated to the EU's research and innovation programme after Tunisia, the European Commission announced on October 22.

The deal, signed at an EU-Egypt summit in Brussels, grants Egyptian research and innovation actors access to all parts of the programme on similar terms to those from EU member states.

Talks on Horizon association started in March 2024, immediately attracting criticism amid accusations of human rights violations in Egypt. There were also suspicions, denied by the Commission, that association talks were offered as part of a quid pro quo deal to stem illegal immigration.

Egypt is the most repressive country yet to associate to the programme, according to a ranking of academic freedom https://academic-freedom-index.net/research/Academic\_Freedom\_Index\_Update\_2025.pdf by the Friedrich-Alexander University in Germany. The country is thirteenth from bottom of the world rankings, between Cuba and Afghanistan. The next most repressive country associated to Horizon Europe is Turkey.

In a joint statement <a href="https://ec.europa.eu/commission/presscorner/detail/et/statement\_25\_2490">https://ec.europa.eu/commission/presscorner/detail/et/statement\_25\_2490</a> following Wednesday's summit, EU and Egyptian leaders affirmed a "shared commitment" to human rights and fundamental freedoms. Commission President Ursula von der Leyen said the association agreement would create opportunities for cutting-edge projects "in vital research areas like water management, sustainable farming and food security, bringing tangible benefits to our societies."

The agreement also extends Egypt's participation in the Partnership for Research and Innovation in the Mediterranean Area, to enhance water management, farming systems and food value chains.

"Egypt's association to Horizon Europe opens a new chapter in our trusted partnership," said research Commissioner Ekaterina Zaharieva. "Our researchers will work side by side to develop solutions that advance science, innovation and shared progress across the Mediterranean region."

New agreement between Brussels and Bern clears its latest hurdle

The Council of the EU has signed off a deal allowing Switzerland to re-associate to the Horizon Europe research and innovation programme, taking a further step towards ending years of limbo for Swiss researchers.

Within the same package, the **Council green-lighted** https://www.consilium.europa.eu/en/press/press-releases/2025/10/21/council-greenlights-switzerland-s-association-to-eu-programmes/ Switzerland joining a swathe of

other EU science and technology schemes, including the Euratom nuclear programme, the ITER prototype fusion reactor being built in France, the Erasmus+ student mobility scheme, as well as Digital Europe and EU4Health.

"In the current complex and evolving geopolitical context, our relationship needs to be expanded and modernised to be better fit for the future," said Marie Bjerre, minister for European affairs in the government of Denmark, the EU country holding the rotating presidency of the Council until the end of the year.

"This is exactly what we achieved today with our decision on Switzerland's association to EU research and innovation programmes as of the beginning of this year," Bjerre said.

Under transitional measures, Swiss researchers have been allowed to apply for Horizon Europe funding since the beginning of the year after Brussels and Bern agreed to a wider package of deals last December.

Today's decision by the Council is the latest step towards the part of that deal covering association to EU programmes being fully ratified by various EU and Swiss institutions.

focusing on building high-quality consortia for selected call topics. This concerns the 'Farm to Fork' and 'Innovative
Governance' destinations of the Horizon Europe Cluster 6: 2026 - 2027 Work Programme. The event takes place on 18

# Strong interest in EIC Accelerator funding with 923 companies applying for the final 2025 cut-off (21 October 2025)

The European Innovation Council received 923 full applications from start-ups and SMEs for the EIC Accelerator 1 October 2025 cut-off. All together, they request almost €7 billion budget. Blended finance continues to be in high demand - 683 companies (74% of total applicants) requested grants combined with equity investments. 33% of the proposals were submitted by women-led companies (CEO, CTO or CSO). The applicants come from 32 different countries (including 12 widening countries), with the highest number of participants coming from Germany, Spain, and France.

#### Next steps

Proposals are now being evaluated by independent experts. The highest ranked companies will then be invited to pitch in front of a jury of investors and business experts between 19 and 23 January 2026. Final decisions on which companies will receive funding are expected by the end of February 2026 and those selected for equity support will be passed to the EIC Fund for investment decisions.

#### Funding opportunities in 2026

This was the last EIC Accelerator cut-off this year. New funding opportunities and the dates for Accelerator full applications will be announced in the 2026 EIC work programme that is expected to be adopted at the beginning of November 2025. Short applications (that give access to the full application stage) can be submitted at any time.

# Innovation gap central in preparation for new European research program (30 October 2025)

In the run-up to the Tenth Framework Programme and the new European Competitiveness Fund (ECF), the discussion about the innovation gap between EU member states is flaring up in Brussels. According to Science Business, MEPs believe that member states with low R&D investments should take more responsibility and make better use of EU structural funds. In another article, Science Business reports that member states disagree on the distribution of ECF resources. Countries such as the Czech Republic, Portugal, and Croatia advocate for geographical distribution. Germany, Sweden, and the European Commission, however, adhere to the principle of excellence. According to European Commissioner Serafin, the fund should remain focused on projects with the greatest impact on European competitiveness.

# Parliament and Council approve dual-use research within Horizon Europe (30 October 2025)

The European Parliament and the Council have approved the European Commission's proposal to allow research within Horizon Europe with both civil and military applications. This is evident from the adopted positions of both institutions. According to Neth-ER, Parliament wants to investigate how the so-called Joint Undertakings in the field of transport can contribute to dual-use innovation. The Council calls for clear funding rules and emphasizes that the civil objectives of Horizon Europe must be preserved.

# Ehler appointed rapporteur for FP10 and Competitiveness Fund (28 October 2025)

The German MEP will lead Parliament's negotiations on the next EU research Framework Programme and the ECF

Germany's Christian Ehler has been appointed lead rapporteur to steer the next EU research Framework Programme, FP10, through the European Parliament. The European People's Party (EPP) MEP will also serve as co-rapporteur for the European Competitiveness Fund (ECF), reflecting the "tight connection" between the two programmes promised by the European Commission.

The Parliament's committee for industry, research and energy will lead on both legislative files, and on the Connecting Europe Facility.

According an EPP spokesperson, Ehler's appointments were decided on October 23, although it is not yet clear if they have been formally registered with the Parliament's secretariat. Ehler himself was not available for comment at the time of publication.

First elected to the Parliament in 2004, Ehler is considered one of its key figures the Parliament's handling of the EU's Framework Programmes. He previously served as a rapporteur for both Horizon 2020 (2014–20) and Horizon Europe (2021–27), and he chairs the Parliament's Panel for the Future of Science and Technology.

Ehler will act as lead rapporteur for FP10, while sharing the role for the ECF proposal with an as-yet unnamed MEP from the Socialists and Democrats (S&D) group.

This is not the first time the German MEP has worked with an S&D colleague, having shared the Horizon Europe file with Romania's Dan Nica.

As lead negotiator, Ehler will engage with fellow MEPs, member states, research stakeholders and Commission officials to bring the legislation to completion, a process that could take several months. For particularly contentious issues, MEPs are expected to hold hearings with experts before drafting a report that will go through amendments and debates ahead of a plenary vote.

### Horizon Europe must remain civilian (23 October 2025)

The European Commission has proposed that from 2026 the European Innovation Council's Accelerator programme may fund defence technologies. This would end what has until now been a legally mandated focus on purely civilian research and innovation in 40 years of EU funding.

The move also foreshadows the Commission's proposal to open the whole of the next iteration of Horizon Europe—the 10th EU Framework Programme for research and innovation (FP10), beginning 2028—to dual-use and collaborative defence research. What will change if Horizon Europe is no longer a civilian-only research and innovation programme? There is wide agreement that even in a civilian programme such as Horizon Europe, much, possibly most, research already has dual-use potential. Even so, the changes proposed raise five fundamental concerns.

#### Budget drain

**To begin with**, applied dual-use and defence research and innovation may require bigger budgets, not least because such work is subject to more stringent regulations and security controls. Whatever the budget for the next Horizon Europe programme, adding defence and dual-use research would divert money from civilian research.

**Second**, the Commission already funds military research through the European Defence Fund. Rather than reorient the EIC Accelerator programme, the Commission could and should have changed the EDF's regulation to allow direct equity investment in scale-up companies.

Similarly, the planned European Competitiveness Fund (ECF) is set to spend €125 billon on defence industry research and development alone: that is clearly the place to fund defence research and scaleup, **not Horizon Europe**.

#### International exclusions

**Third**, many of the changes envisaged by the Commission for the immediate future of research and innovation policy concern the exclusion of third countries. It proposes to limit defence projects to entities in the EU, the European Economic Area and Ukraine, excluding other countries associated with Horizon Europe such as the UK. Exclusions could also apply to dual-use calls, and to private companies owned by entities outside the EU.

If in future, all of FP10 "may support dual-use actions", as the current draft regulation proposes, how attractive will it be to third countries that have little idea of which parts of the programme they can access? How attractive will it be to top EU researchers if their peers in the UK or Switzerland might be excluded from calls in artificial intelligence or quantum computing?

Dual-use calls would impair the programme's openness in terms of publication as well as collaboration. Who will decide what data and results have the potential for military applications and are, therefore, exempt from open science mandates? Opening Horizon Europe to dual-use research could upend 10 years of the Commission-led drive towards open science.

#### Discovery deficit

**Fourth,** including dual-use calls in Horizon Europe has implications for the balance between fundamental and applied research. The current programme has already skewed towards the latter, despite the Commission's promise—and legal obligation—to balance fundamental and applied research in collaborative calls.

In the proposal for FP10, the Commission envisages funding research up to technology readiness level 8, far beyond discovery research (TRLs 1-3) and the validation of technology (TRLs 4-6). It also seeks the possibility of funding (expensive) large-scale product validation and market replication at still higher TRLs—which, again, should be the job of the European Competitiveness Fund. Since dual-use calls will likely operate mostly at higher technology readiness levels, they would tilt the balance yet further towards applied research.

**Fifth**, opening Horizon Europe to dual-use research would fundamentally affect researchers' self-understanding. How will they respond if the programme admits explicitly military applications?

Indeed, if the current, legally mandated civilian focus of Horizon Europe can be changed easily to admit military applications, it suggests that FP10 could also be further tailored to military uses, beyond what the Commission currently proposes. How would Europe's researchers feel about such a shift?

In the current geopolitical climate, we should not be surprised that the Commission might wish to articulate the military potential of Horizon Europe to underline the need for member-state investment. But why is the Commission not articulating the civilian value of Horizon Europe just as loudly? Research and innovation are bafflingly absent from Europe's discussions to develop global partnerships, for instance through the Global Gateway.

The implications of opening Horizon Europe to dual-use and military research are wide and deep. Researchers and their institutions need cast-iron assurances from the Commission that it will remain a civilian research programme. And for exceptional circumstances where dual-use research and innovation will be encouraged, we need an urgent debate about the implications for the sector.

# Six international consortia receive funding to improve soil moisture retention in Sub-Saharan Africa (24 October 2025)

These grants are awarded as part of the NL-CGIAR Water-Food Nexus call. The transdisciplinary consortia will study the scaling of soil moisture retention practices for smallholder farmers in rainfed agri-food systems. With the increased severity of dry spells, increasing the moisture holding capacity of the soil works as a buffer against agricultural production losses. The research focuses specifically on socio-economic and governance aspects of scaling soil water retention practices. The research projects take place in Kenya, Ethiopia, Uganda, Benin, Burkina Faso, Niger, Mali en Nigeria.

The NL-CGIAR water-food nexus call facilitates cooperation between researchers from CGIAR Research Centres, both Sub-Saharan African and Dutch knowledge institutes, as well as stakeholders from National Agricultural Research and Extension Services (NARES) and cooperation partners from local governments. The projects' summaries are available to read below. Projects will start in spring 2026.

NWO has opened the call Research Infrastructure: national consortia 2025-2026 for proposals. Researchers from all disciplines are invited to form consortia for facilities that enable scientific breakthroughs. With the investments in this research programme, NWO is strengthening the research infrastructure that Dutch knowledge institutions make available to the entire research community.

Research infrastructure (RI) consists of facilities, resources and services that the Dutch research community can use to conduct groundbreaking scientific research. This call offers the opportunity to establish new lines of research or to deepen existing ones.

The aim of this call is to create a coherent package of investments, for example in the form of:

- an RI for a certain type of measuring device;
- an RI for developing or opening up a collection of data or samples.

#### Budget and deadlines

The grant ceiling is raised with 10 million euros compared to the previous round and set at 30 million euros for this Call for proposals. A minimum of 1.5 million and a maximum of 10 million euros can be requested per project. In addition, the consortium is required to fund at least 25% of the total project itself. Funding from (private) co-funders is not mandatory but is also not excluded.

The deadline for submitting a letter of intent (mandatory) is 2 December 2025. Full proposals must be submitted before 24 March 2026.

#### NWO invests in research infrastructure

This call is part of NWO's efforts on research infrastructure. Together with its partners, NWO works on broad accessibility, renewal and continuity of research infrastructure. This includes highly specialised equipment such as large telescopes or high field magnets, but also digital infrastructures, such as scientific computer networks and supercomputers, and data and sample collections or biobanks. Despite earlier reports that the Doctoral grant for teachers would end after 2026, it will continue after all. Two additional rounds will be organised in 2027. This opportunity has arisen due to, among other things, remaining funds from previous years.

The grant, which enables teachers to conduct PhD research alongside their work in education, was previously labelled by NWO and other parties involved as essential for the quality and depth of education. The announced discontinuation of the grant therefore led to concerns about the loss of scientific connection in the field of education.

Thanks to the financial resources that are now becoming available, NWO will be able to issue two more calls in 2027. This will give motivated teachers the opportunity to realise their research ambitions after all.



There is no ready-made recipe for a successful climate transition. What is clear, however, is that science and practice must work together to determine the desired direction of transitions. The Climate Research Initiative Netherlands (KIN) subsidy call "Transformative Practices and Processes for Climate Transitions" invites societal organisations and knowledge institutions to further develop, test or scale up transformative practices and processes for just climate transitions.

#### About the call

Systemic change is necessary for the transition to make the Netherlands climate-neutral and climate-resilient. Knowledge can make a real difference in shaping the climate transition. However, the effective use of knowledge also requires a transition in how we do scientific research. Current research practice is often characterised by disciplinary specialisation, competition between consortia and fragmentation of knowledge, and falls short when it comes to tackling complex societal challenges such as climate transitions. With this call for proposals, KIN is focusing on a new scientific practice with a transition mindset: an attitude and way of working that prioritises collaboration between researchers and societal organisations, values different forms of knowledge equally, and offers space for transformative approaches that contribute to just system change.

This call for proposal invites anyone who wants to connect science and practice for just climate transitions t experiment and to develop, test or scale up transformative practices and processes for just climate transitions. From societal organisations, researchers and the creative sector that (want to) use facilitating working methods, processes and inbetween spaces for system change and the development of a transition mindset to pioneers who are already working on (sustainable) alternatives for transformative social impact. It is important that practice forms the starting point and that methods are scalable and transferable. Individuals or consortia can apply for funding.

#### The programme supports projects that:

- promote transdisciplinary collaboration between practice and science,
- use facilitating practices, processes and spaces that contribute to systemic change,
- and strengthen the transition mindset among researchers and practice partners by supporting them and offering guidance.

### **Budget and duration**

A budget of €500,000 is available for this call for proposals. A maximum of €50,000 can be requested per proposal. The deadline for submitting applications is **Tuesday, 27 January 2026**, **before 14:00:00 CET**. For this call for proposals, we use a peer review principle, and the main applicants are also the assessors.

#### 149 Vidi applications granted to talented researchers (23 October 2025)

NWO has granted a maximum of 850.000 euros to 149 scientists from the domain Science (ENW), Applied and Engineering Sciences (AES) and Social Sciences and Humanities (SSH) domains, as well as Health, Research and Development (ZonMw). With the help of the Vidi grant, the talented scientists can start their own line of research and further develop their talent.

The topics the scientists will research vary greatly. While one of the scientists will research the influence of old writers and artists on the queer community, the other will make AI more energy efficient by researching how our brains process videos. Another researcher will research certain brain- or mental health factors that influence the use of substances in adolescents and yet another will research how we can use swarms of robots to inspect constructions such as old bridges.

This is just a small sample of the innovative Vidi research project awarded in this round.

- 5. Sprawling servers: Rural residents' engagements with hyperscale data centers and promised infrastructural integration; *Dr. S. Ketterer, Wageningen University & Research*
- 6. Transformation under pressure: Harnessing plural risk images for governing urban water crises (UnderPRESSURE); Dr. J.K.L. Koehler, Wageningen University & Research
- 7. **GPS4FoodSafety:** Dr. G.IJ. Salentijn, Wageningen University & Research

Of the 149 projects that have been granted within the Vidi-round 2024, 57 were granted to projects belonging to ENW, 54 to SSH, 15 to AES and 23 to ZonMw.

#### Facts and figures

Vidis are awarded annually by NWO. Among the 778 preliminary applications, 149 are awarded. Of the 778 applications, 393 are men, and 377 are women. Of 8 applicants, the gender is unknown. Of the 149 awards, 70 male and 79 female applicants are awarded. The award rates are 17.8% en 21% respectively.

This round, NWO has been able to grant additional funds to honor more high-quality proposals. This enables NWO to give talented researchers a helping hand in times of cutbacks in research and science.

#### Online dashboard

NWO wants to contribute to openness and transparency in and about publicly funded scientific research. That is why we have recently started publishing figures on gender and the disciplines of allocated research in an online dashboard. The dashboard will be further developed in the coming period, with ZonMw data being added in the future and an English version becoming available.

Researchers with exciting, high-risk, high-gain ideas are invited to submit their proposals and compete for a chance to receive €100,000 to develop their research over the course of one year.

#### Outside-the-box thinking with impact

Open Mind funds innovative research proposals that break through conventional thinking frameworks and use technology for sustainable social impact. Think of ideas that, for example, transform education, promote inclusivity, tackle climate issues or enable new forms of communication. The call invites researchers from all disciplines who tackle global challenges with groundbreaking and creative solutions.

#### Key changes compared to 2025

Compared to the previous round, a number of important changes have been made:

- The maximum budget per application has been increased to €100,000.
- The number of projects to be awarded has been increased to a maximum of 10.

The assessment criteria continues to focus on originality, creativity, quality and impact.

# State of Al 2025: Europe lags behind the US and China in artificial intelligence (30 October 2025)

Despite all efforts, the EU continues to largely lag behind the US and China in artificial intelligence. This is evident from Air Street Capital's annual State of AI report. The report shows that the US leads by a wide margin in private investment and AI supercomputers, while China performs best in open AI models. However, the EU has overtaken China in private investment. Furthermore, the report shows that AI has become mainstream and has also gained momentum commercially and industrially. However, geopolitical tensions between China, the US, and the EU are playing an increasingly important role in AI policy.

### European Commission presents defense roadmap (30 October 2025)

The European Commission has presented the new European roadmap for defense. The plan focuses on joint investments, industrial collaboration, and technological innovation. The Commission aims to accelerate innovation through dual-use applications and so-called defense tech alliances, which connect technology companies with armed forces. According to Science Business, the plan contains few concrete measures or new R&D funding. However, starting in 2028, dual-use projects will have access to the European Competitiveness Fund and Horizon Europe. Subsequently, the European Parliament and the Council have expressed their support for the European Defence Industry Programme, which should support the implementation of the roadmap. This program includes a "buy European" principle to strengthen cooperation within the EU.

# EPO sees strong growth in patent applications by public research organizations (30 October 2025)

Public research organizations have almost doubled their number of European patent applications in twenty years. This is according to a study by the European Patent Office (EPO). According to the EPO, the figures show that public research organizations are increasingly able to valorize their knowledge. They now file patents themselves much more often than universities, which points to stronger technology transfer structures. Most applications come from a few large institutions, such as the French CNRS and the Fraunhofer Society in Germany. EPO President António Campinos states that the figures demonstrate that public research is "one of Europe's greatest strengths," but that more collaboration is needed to translate research results into technology more quickly.

Speaking to Science Business, MEP Matjaž Nemec called Horizon "one of the key programs to strengthen Europe's competitiveness and innovation." Negotiations with the Council on the final budget will begin on November 4. An agreement on the 2026 budget is expected before the end of the year.

The Commission sees a clear role for innovation and research in promoting European competitiveness and independence in the 2026 work programme. In the field of education, initiatives for digital skills and European school alliances are planned.



#### Plans for an independent Europe

Innovation must contribute to the EU's independence, according to the 2026 work programme https://ec.europa.eu/commission/presscorner/detail/en/ip\_25\_2414 and https://commission.europa.eu/document/download/05d3777d-5d73-456d-bf56-38caa77d53c8\_en?filename=2025-CWP\_0.pdf . During the presentation https://ec.europa.eu/commission/presscorner/detail/en/speech\_25\_2462, Ursula von der Leyen, President of the European Commission, emphasized the importance of the Draghi Report. For example, the Commission will focus on simplifying legislation and developing critical technologies next year. To this end, the Commission will present the 28th regime and the Innovation Act in the first quarter of 2026. The "fifth freedom" also plays a critical role in promoting the Single Market and the European Research Area Act. In the field of education, initiatives for developing digital skills and European school alliances are on the agenda. It is striking that the work programme does not mention the announced vocational education strategy and the Lab to Unicorn Initiative.

# EU countries divided over geographical rules in Competitiveness Fund (23 October 2025)

The geographical distribution of EU funding for innovative technologies is set to be debated at the highest political level, after it emerged as a possible source of disagreement during a meeting of European affairs ministers on October 21. The question of whether to include geographical criteria in the selection of projects is a long-standing debate when it comes to EU research funding, but the European Commission's plans to launch a €234 billion European Competitiveness Fund (ECF) have pushed those divisions to the fore during wider budget talks.

During Tuesday's meeting of the General Affairs Council, several European affairs ministers, mostly from countries that benefit from measures to widen participation in Horizon Europe, called for geographical balance in awarding ECF funding. Germany led the charge in opposition to this idea, warning that it would mean corresponding cuts in cohesion funds. These are the EU funds set aside to strengthen the economic, social and territorial cohesion of the Union. Supporters of geographical criteria argue that, without safeguards, the ECF risks further entrenching innovation and competitiveness gaps within the EU as applicants from more developed economies are better equipped to win funding. Opponents counter that to compete with the US and China, ECF funds must be directed where they will have the largest impact.

The issue came up during a debate on the Commission's 2028-34 EU budget proposal, focused on the second heading, which includes the Horizon Europe research and innovation programme and the ECF, which will invest in strategic technologies that are closer to the market.

The debate will inform a "negotiating box" document that the Danish presidency of the Council plans to submit to EU leaders ahead of the European Council meeting in December. The negotiating box will indicate progress on budget talks made at the technical level and identify elements that should be discussed at political level.

During the debate Inês Domingos, Portugal's secretary of state for European affairs, said the principle of excellence when awarding funds is "fundamental," but there should also be mechanisms "that allow the more peripheral member states and regions, and the ones that have particular constraints, to be able to fully participate in boosting European competitiveness."

Czech minister Martin Dvořák agreed that measures to broaden access to funds do not undermine excellence, but are a way to spread excellence. "Widening participating should be taken care of in Horizon Europe, but also in the Competitiveness Fund," he said.

"One of the proposals is to earmark part of the ECF funds for certain member states that are less experienced in direct governance, or to have additional measures focused on member states whose [gross national income, GNI] per capita is below the EU level." Dvořák said.

Croatia's state secretary Andreja Metelko-Zgombić likewise expressed support for the excellence principle, but called for mechanisms to ensure a geographical balance, "either including predefined allocations directly to entities from member states whose GNI per capita remains below the EU27 average, or through dedicated calls for proposals targeting those member states."

#### Germany and Sweden opposed

On the other hand, several member states argued that excellence should be the only criterion for awarding funding. Among the most vociferous opponents of replicating Widening measures in the ECF was Germany's ambassador to the EU, Thomas Ossowski.

"We can't be talking about geographical distribution, we are strongly against this," Ossowski said, adding that this was the purpose of the first heading of the Commission's proposal, which includes cohesion funds. "When the excellence principle is called into question in the Competitiveness Fund, then the resources under heading one would be called into question."

Sweden's minister, Jessica Rosencrantz, was similarly adamant that both the ECF and Horizon Europe should be guided by excellence. "Allocating money on grounds other than excellence will certainly not help to create European global champions. There is another, larger heading for cohesion. Let's not mix them up or blur objectives," she said. The issue is deeply connected to broader debates around EU spending. The reason many member states are asking for fair geographical distribution in the ECF is likely that the first heading of the Commission's proposal foresees a reduction in the share of the EU budget that is pre-allocated at national level, said Eulalia Rubio, senior research fellow at the Jacques Delors Institute.

Under the current long-term EU budget, agriculture and cohesion policy account for 62% of all spending, but their allocation in the new proposal has dropped to 44%

https://institutdelors.eu/content/uploads/2025/08/20250731\_Policy\_Brief\_Ripe\_for\_Reform\_Hansum\_Lindner\_Redeker\_Rubio.pdf as the Commission looks to inject greater flexibility into the budget and to tie spending to national reforms.

While widening participation has always been a major topic in Horizon Europe negotiations, "I believe it's now much more important because there's an important cut in the pre-allocated spending," Rubio told Science|Business. "Since the pot of funds for heading two has increased, [member states] want to have more capacity to receive part of this pot." However, while Widening measures make sense in Horizon Europe, which has broad goals including building a unified European Research Area and supporting basic research, the ECF has different requirements as it is more focused on industrial policy, Rubio said.

She warned that including geographical distribution criteria could "kill the impact of the ECF." The EU must be able to select only the most excellent projects, "otherwise, you won't be able to compete with other industries in China or the US that have much more financing capacity," she said.

The Commission has launched a call for evidence and a public consultation https://ec.europa.eu/info/law/better-regulation/have-your-say/initiatives/14952-Advanced-Materials-Act\_en, seeking input from all interested stakeholders to the forthcoming Advanced Materials Act. A key deliverable of the Competitiveness Compass, the Advanced Materials Act will aim at establishing a strategic framework for advanced materials that is crucial for industrial leadership, strategic autonomy and competitiveness in the EU. Advanced materials are intentionally designed and engineered materials with innovative properties and functionalities, which can be used in products from wearable electronic devices to electric vehicles.

The Act will support the research and innovation (R&I) process, from design and development to manufacturing and deployment, while at the same time addressing key issues, such as the lengthy time from the design until deployment and commercialisation, and the expansion of production capacities of advanced materials in the EU. It will streamline regulatory processes, boost EU competitiveness, and foster a more sustainable and circular economy.

The call for evidence and the public consultation are open for contributions until 13 January 2026 on the Commission's 'Have Your Say' portal. Everyone is encouraged to participate and contribute to the design of a legislative framework that will facilitate the seamless deployment of advanced materials across the EU. The Advanced Materials Act is expected to be proposed in 2026.

#### Background

Advanced materials are essential for the EU's transition to a sustainable and competitive economy. Characterised by new or enhanced properties and targeted structural features, they play an important role in sectors such as clean and deep tech, as well as defence and space. The Advanced Materials Act will build upon the Communication on Advanced Materials for Industrial Leadership of February 2024, which aimed to align EU and Member State R&I priorities and objectives for advanced materials, strengthening the European advanced materials ecosystem and increase investments.

### Building the future of EU agriculture with young farmers in focus (21 October 2025)

Agriculture in Europe is faced with a major challenge, an ageing population. And yet, young farmers are key to the EU's food security and to lively rural areas. To address this, the Commission has presented a strategy for generational renewal in agriculture. It aims to support young farmers and attract more people to farming.

Currently, the average age of an EU farmer is 57 and only 12% are under 40. To keep farming resilient and attractive, young people must have the right conditions to build their lives and careers in rural areas. This new strategy sets a clear roadmap for how to achieve this, aiming to **double the share of young farmers in Europe by 2040**. The strategy identifies five key levers for action — access to land, finance, skills, fair living standards in rural areas, and

#### Concrete initiatives include

support for succession.

- introducing a 'starter pack' for young farmers in the next common agricultural policy, including a lump sum of up to €300 000, to facilitate their entry and establishment in the sector
- better targeting of funds in favour of young farmers
- working with the European Investment Bank to facilitate access to finance
- making it easier for new entrants to start farming, thanks to a European Land Observatory, which will help farmers access available land, support farm succession, inform policy, and prevent land speculation
- inviting young farmers to participate in Erasmus for Young Entrepreneurs https://www.erasmusentrepreneurs.eu/ so they can learn good farming practices abroad or diversify their revenue by learning from other sectors
- promoting good living conditions in rural areas while supporting local development and youth and women's involvement
- co-funding farm relief services that replace farmers during illness, holidays, or caregiving, to improve their work-life balance.

The strategy will be implemented at multiple levels: through the current and future common agricultural policy, complementary EU policies, initiatives by stakeholders, and national actions.

Efforts at the national level will be crucial for its success. That is why the Commission is also urging EU countries to invest at least 6% of agricultural spending into measures promoting generational renewal. On top of this, the strategy includes developing national strategies by 2028 that should address challenges and define support measures for young farmers.

# Ukraine is working with partners on a science system rebuilding plan (30 October 2025)

#### Caretaker Cabinet Wants Greater Focus in Industrial Policy (30 October 2025)

Six of the most promising markets for the Netherlands: semiconductors, biotechnology, defense applications, digital services, mechanical engineering, and innovative chemistry. Before the autumn recess, the Cabinet approved the new industrial policy, which focuses on these markets. They were selected based on their economic potential, strategic economic positioning, and contribution to solving societal challenges. Minister Karremans wants to develop a program with concrete goals and actions in collaboration with the business community, modeled on the current approach to semiconductors, Project Beethoven. An independent advisory report from former ASML CEO Wennink on strengthening the Dutch investment climate and future earning capacity is expected by the end of 2025. The Netherlands Institute for War, Safety, and Innovation (AWTI) will issue an advisory report around that time on structural and targeted investments in research and innovation.

### Rathenau: Most scientists stay or return(30 October 2025)

Most scientists stay in the Netherlands or return after a while. This is the conclusion of the Rathenau Institute in its report "Honkvast, uit of homerun," which examines the percentage of researchers who stay in the Netherlands and the percentage who leave or return. Between 2008 and 2023, only 14% of scientists left the Netherlands. During this period, a total of 11% more scientists arrived in the Netherlands than left. In the technical sciences, this percentage is 40%. According to the researchers, it is still too early to comment on recent developments, such as the Schoof government's budget cuts, the Balanced Internationalization Act, and geopolitical unrest.

# Election debate on research and innovation: 'You have to dare to stand up for scientists' (22 October 2025)

During election time, knowledge, research and innovation rarely top the list of debate topics. Yet they are crucial to solving societal challenges. How much extra should be invested in research and innovation, and to what extent should politics interfere with the system? These questions take centre stage in the election debate 'The power of knowledge: choosing progress', organised by the Kenniscoalitie on 21 October.

Under the eyes of both a live audience and online viewers, Luc Stultiens (GroenLinks-PvdA), Wendy van Eijk-Nagel (VVD), Jan Paternotte (D66) and Marcel Hanegraaff (CDA) debate the future of research and innovation at Nieuwspoort press centre.

#### Knowledge as the trump card of the Netherlands

Kenniscoalitie chair Marcel Levi underlines the importance of Dutch research as he opens the debate: 'Housing, energy, climate, healthcare, mobility – without knowledge and innovation, we simply won't solve any of these problems. Knowledge is the trump card of the Netherlands.'

All participants agree on this point, though they differ on implementation. Paternotte calls it 'the most important debate of these elections': 'It's about how we will earn our money in the future.' He argues that the Netherlands must once again become a leader in research and innovation. Hanegraaff warns that the country is falling behind in the rat race between China and the US. 'We want to invest heavily, but more is needed. We are regulating our economy to death.'

Stultiens believes that additional investment in research and innovation is inevitable for a healthy economy. 'Economists and companies are saying it: invest in this. It's unbelievable how much has been cut from the budget this past year. We say: scrap all those budget cuts.'

Van Eijk-Nagel takes a somewhat more optimistic view of the Netherlands' current position. 'The biggest challenge is to keep it that way,' she says, stressing the importance of an attractive business climate and the growth of start-ups and scale-ups. 'On economic matters, we will absolutely find common ground.'

#### The Lisbon target

The first topic concerns the Lisbon target, the European goal for countries to spend 3% of GDP on research and development. In practice, this would mean an increase of 2 billion euros by 2026 and 3.5 billion by 2029 in additional public funding, according to the Kenniscoalitie's statement. Will parties reach that goal with their election plans? 'That's still not enough, it won't get us there,' argues Paternotte, whose party aims for around 10 billion euros per year. Stultiens also finds the proposed increase too modest.

Hanegraaff and Van Eijk-Nagel point to the role of the private sector in providing additional funding. 'Most investments should come from there,' says Hanegraaff. 'That's how you really create a catalytic effect.' Van Eijk-Nagel adds: 'You can't aim to meet the target and at the same time cut business incentives. That's contradictory.' 'But this debate is precisely about the public share,' Stultiens counters. 'We all share the same goal, but the question is: how much are you really willing to spend?'

#### Room for curiosity-driven research

Should research funding primarily go to areas that strengthen the Netherlands' earning capacity? The VVD thinks so. 'When it comes to public money, the priority should be the country's earning power – and more broadly, solving societal challenges,' says Van Eijk-Nagel. What about fundamental fields like literature, philosophy and archaeology? 'For us, those have less priority.'

D66 and CDA disagree. They point to ChatGPT, Silicon Valley and communications technology as innovations that originated from curiosity-driven research. 'If you only invest in research that delivers short-term results, you destroy science,' says Hanegraaff. 'There must always be room for research driven by curiosity. It's proven that this leads to major innovations in the long run.'

Paternotte is frustrated that parliament increasingly questions research without direct economic benefit. 'We must stop pitting research fields against each other.' GroenLinks-PvdA agrees. 'By only demanding economic returns, you turn universities into pre-training grounds for the corporate sector,' says Stultiens. 'That's selling them short.' He points to recent cuts proposed by the previous coalition, 'hardly opposed at the time – even though they came from the PVV. You have to dare to stand up for scientists whose work doesn't immediately make money.' Hanegraaff adds: 'The VVD's market-driven approach turns universities into companies expected to deliver output. That's a fundamentally wrong way to look at science.'

#### International talent

The parties diverge further on whether the Netherlands should continue to welcome international talent. The VVD is the only one opposed. 'International talent is welcome in the Netherlands, and we absolutely need it,' explains Van Eijk-Nagel. 'But we make more targeted choices. The link with the labour market is crucial. That means not everyone can study whatever they want, because that creates bottlenecks elsewhere.'

Paternotte criticises this position, recalling that calls to reduce international students began two years ago when VVD and CDA wanted to ban English-taught bachelor's programmes. 'Now the cuts are still here – just without a "how".' Hanegraaff adds nuance: the number of students, including international ones, is already declining, and he supports

making it easier for universities to introduce admission limits. 'But not in cities like Maastricht and Groningen, where they badly need those students.'

'In Groningen, hundreds of people have already been laid off,' Paternotte counters. The CDA's proposed cuts will only make that worse. 'If you mention Groningen and Maastricht – this will be a disaster there.'



Universities need to know what government policy will look like. They need predictability Jan Paternotte, D66 He also stresses the importance of international talent for business. 'Eighty percent of companies and entrepreneurs have lost trust in government because of unpredictable policies. Companies like Shell and Unilever are cutting investments, ASML is asking for support to stay afloat. Saying "then no more expats" – that's a luxury we can't afford.' Stability also matters for education, he adds. 'Universities can already choose English-taught tracks, but they need to know what government policy will look like. They need predictability.'

#### Standing up for academic freedom

Finally, recent developments at home and abroad raise questions about how academic freedom is safeguarded. Governments worldwide are increasingly interfering with the content of education and research. Hanegraaff, who also works in academia, calls it a slippery slope. 'The pressure on scientists is really growing,' he says. He believes academic freedom is legally well protected, but the real issue lies in political norms: 'What kind of criticism of scientists is being fuelled in politics? That bar needs to be raised again.' He vows to act on this. 'The erosion of democracy always starts with the criticism of scientists, judges and the media. You have to do everything possible to prevent that.'

Paternotte shares this concern. 'It's become almost normal to call for the dismissal of a scientist after they say something controversial. Or to demand that a university board step down after a protest gone wrong.' He warns: 'That's already happening in the United States. If we don't put up a barrier here, things will go very wrong.' D66 therefore calls for constitutional protection of academic freedom.

Van Eijk-Nagel agrees on the importance of academic freedom but finds constitutional anchoring a step too far. 'If there's one place you should feel safe, it's at the university,' she says. 'But that freedom is best secured through dialogue and shared responsibility.'

GroenLinks-PvdA warns that academic freedom in the Netherlands has long been under pressure. 'It's code red. Coalition parties have undermined freedoms, questioned individual researchers and called for boards of trustees to be dismissed,' says Stultiens. He too advocates stronger constitutional safeguards and welcomes Van Eijk-Nagel's words. 'Let's agree to jointly call out any party that crosses that line. That's the only way to truly protect academic freedom.'
